1. APOLOGIES FOR ABSENCE

5911 Apologies were received and accepted from Brian Archer, Rhydian Vaughn and Ranil Jayawardena.

2. DECLARATIONS OF INTEREST

5912 None

3. TO APPROVE MINUTES OF MEETING HELD ON 8th JULY

5913 Approved and signed as a true reflection of Meeting.

4. TO DISCUSS MATTERS OF CRIME AND DISORDER

5914 The neighbourhood watch report was reviewed.

OPEN FORUM: The meeting was temporarily adjourned

5. TO RECEIVE AN UPDATE ON GREENWAY REGISTRATION AND RESURFACING

5915 Ivan Gosden reported that it has now been established following communication with the Commons Registration Department the track known as Greenway does not form part of the Green. Greenway was not included in the original registration of the Green in the 1970's and it is not possible for it to be added at a later date.

The Borough Council has now agreed to progress and manage the resurfacing of Greenway using S106 money that is available to the Parish. This will provide members of the public with improved access to the allotments and the play areas on the village green.

6. TO RECEIVE AN UPDATE ON REQUEST FOR TRAFFIC CALMING SURVEY IN BRAMLEY ROAD AND OLD READING ROAD

5916 Ivan Gosden reported that Alfred Nortey who works for Andrew Kettlewell has ordered traffic surveys on Bramley road and Old Reading Road it is likely that they will take place during the week commencing 21st September. A total of 3 surveys are involved and will take place over 5 - 7 days:

- Heavy Goods Vehicle (HGV) survey
- Traffic volume by direction

- Traffic speed classifier

A resident living in Taylors Farm has requested speed bumps on Gaiger Avenue. Although Gaiger Avenue is unadopted at present the survey team will include Gaiger Avenue in the survey which could help in getting a sensible speed limit set when the road is adopted.

7. TO RECEIVE AN UPDATE ON PLANNING APPLICATION FOR ENTRANCE AND PLOTTING AT THE BURIAL GROUND

5917 Bruce Batting reported that he was still awaiting information needed to complete the Planning application. This will be progressed as soon as possible. Clerk to look at progressing the plotting of the burial ground. Ivan Gosden reported that Bob Politt and Peter Gould have requested a meeting in October to take matters forward regarding the removal of the rest of the hedgerow between the churchyard and the new burial ground and gates.

5918 The lady who owner the car involved in the accident with the planter has paid for the cost of the replacement planter in full.

9. TO DISCUSS SUPPORT FOR PUBLIC INQUIRY INTO SOUTH EAST WATERS DRAFT WATER RESOUCE MANAGEMENT PLAN.

5919 Ivan Gosden reported that the clerk had received an information pack from the Whitewater Valley Preservation Society informing Parish Councils about a Public inquiry into South East Water's Draft Water Resource Management Plan – to 2035. The WVPS is encouraging all Parish Councils to write to the inquiry inspector to associate themselves with the inquiry and to support the WVPS response to the Plan.

Following a discussion the Parish Council agreed register their support. Clerk to prepare a response.

10. TO DISCUSS A LETTER RECEIVED FROM A RESIDENT REGARDING ACCESS TO THE GREEN AND DITCH CLEARING.

5920 The letter was reviewed by the Parish Council and the following actions agreed.

Bruce Batting will remove orange fencing and from the Village Green and clear the area of the ditch containing grass cuttings.

The Borough Council will be managing the resurfacing of Greenways and will deal directly with the contractors.

Bruce Batting agreed to talk to Peter Eade of Hampshire Highways North regarding Drainage issues in Goddards Lane. Bruce Batting explained that work had been scheduled to take place on this road in 2007 but changes in management and contractors at the Borough Council had resulted in a delay.

11. TO RECEIVE AN UPDATE ON FOOTBALL PAVILION PROJECT

5921 Ivan Gosden reported that a football Pavilion meeting took place on 27th August, attended by Sherfield FC, Loddon Sports, Parish Council members, Sasha Nichols (Hampshire FA) and Steve Welch (B&D). Sasha Nichols explained the process for applying for funding from the football foundation and said if the project met with their criteria they may fund up to 50% of project. Sasha Nichols took away latest plans to check them against criteria set by the Football Foundation.

Ivan reported that Sherfield FC had received a letter from the local football league about the poor internal decoration of the Pavilion. Sherfield FC have now painted the inside of the Pavilion and installed new cupboards.

12. TO RECEIVE AN UPDATE ON THE DITCH CLEARING PROGRAMME FOR 2009/2010 TO INCLUDE CENTRE DITCH

5922 Bruce Batting reported that he was involved in discussions with Bulpitts about clearing the ditches behind Loddon Sports Pavilion. Bruce Batting reported that the planning application for Centre Ditch has been submitted.

Ivan Gosden reported that quotes had been received for removing willow and then either burning the wood or chipping and removing it.

Following a discussion it was agreed that the Willow should be chipped and removed from site. This was proposed by Bruce Jones and seconded by Bruce Batting and unanimously accepted.

The Clerk agreed to ask Thurley Plant Hire and Dave Millar Plant to provide quotes for chipping and removing

14. TO DISCUSS DONATION FOR POPPY WREATHS FOR REMEMBRANCE SUNDAY

5924 Ivan Gosden reported that the Poppy Wreathes for Remembrance Sunday had been ordered and delivered. The Royal British Legion ask for a donation to cover costs and postage. It was agreed to make a donation of £100, this was proposed by Bruce Batting and seconded by David Leivesley and unanimously accepted.

15 . TO UPDATE COUNCILLORS ON THE LITTER WARDEN GRANT IN 2009/2010

5925 The clerk confirmed that the grant for both Parish and Borough litter wardens has not changed.

16. TO UPDATE CONCILLORS ON ROUNDABOUT WILDFLOWER SURVEY

5926 The chairman reported that Liane Green had requested a wildflower survey on the roundabout at the beginning of the summer. The clerk is still awaiting an update.

17. TO INVITE KEN CLARK TO JOIN A COMMITTEE

5927 It was agreed that Ken Clark would join the Finance committee and the Planning committee. These were proposed by Bruce Batting and seconded by Bruce Jones for Finance and proposed by Sally Hennessey and seconded by Lucy Marshall for planning and was unanimously accepted.

15. TO RECEIVE REPORTS & RECOMMENDATIONS

(a) 5930 Planning

Application No: BDB/70924

Location: 8 Premier Court, Mill Close, Sherfield on Loddon

Proposal: Erection of gable wall to provide extension to loft with construction of 2 no. dormer windows to east elevation. Installation of rooflights to west elevation. Construction of external staircase.

PC Decision: Objection. The development would reduce the available parking area whilst also creating a need for further parking. The inclusion of an exterior staircase is not in keeping with other properties in the area. The councillors felt strongly that this would be an over development of the site

Application No: BDB/70940

Location: 3 Hams Corner, Sherfield on Loddon, Hook, RG27 OHP

Proposal: Erection of single storey rear extensions and insertion of first floor window to left side elevation

PC Decision: Objection. This is an over development of the plot and has a long uninterrupted expanse of brickwork. The Parish Council believe that the development would lead to insufficient parking due to the loss of garage space.

Location: 42 Northfield Road, Sherfield on Loddon, Hook, RG27 OHP

Proposal: Erection of two storey and single storey side extensions and erection of a single storey front extension

PC Decision: No Objection. The parish council believe that the development is appropriate for the size of plot but would like to note their concerns about flooding in the area due to loss of natural soakaway and a lack of adequate infrastructure.

Proposal: amended application, to include conversion of existing garage to living accommodation

PC Decision: Objection. The Parish Council objected to the amended planning application for the same reasons given previously. This is an over development of the plot and the vast expanse of uninterrupted brickwork along the neighbour's boundary is unacceptable. The loss of the garage will lead to a further reduction in the already limited parking space and the Parish Council does not believe that the proposed number of parking spaces matches the allocation approved in the original planning consent.

(b) Allotments

5931 Bruce Batting reported that the allotment competition had taken place and the winners were, 1st place Mrs Sue Morse, 2nd place Mrs Maria Nind and in 3rd place Mr D Farrow. A winner's cup and plaques for the 2nd and 3rd places were awarded at the Sherfield show. The annual allotment meeting will take place on the 20th October. Simon Buckingham has informed the clerk that the allotment grant has been approved by his department and is awaiting final approval by the Borough Councillors, this should be finalised by end of September. Two plot holders have given notice on their plots, new plot holders have been informed. Plot 51 and the surrounding skip area will be cleared by Bulpitts and the plot rotovated. Plots are fully let with 2 people in Parish on the waiting list and 8 out of Parish.

There have been complaints about dog mess on the plots, clerk to put a notice in the Loddon Link.

It was agreed that Mrs Varney who is taking over plot 51 can erect a small greenhouse on the plot.

A skip will be ordered for the last week of September.

Bruce reported that contractors will be relaying the path the runs alongside the allotments as some of the paving slabs have raised edges. The privet hedge running alongside the footpath from Bow Grove to the allotments will also be cut back in September.
