ORGANISATIONAL LICENCE

Issued to: Amphibian and Reptile Conservation Trust



OVERVIEW This Organisational licence is issued to the Amphibian and Reptile Conservation Trust (ARC) to enable employees and authorised volunteers to undertake various work-related activities potentially affecting a range of protected species and their habitats in England. ARC is responsible for the conduct of all activities performed under the authority of this licence. Only ARC employees or registered ARC volunteers are entitled to use this licence. Reference WML - OR10 The following annexes are an integral part of this licence: Organisational Licence WML-OR10 (a) Surveys WML-OR10 (b) Possession Issued under The Conservation of Habitats and Species Regulations 2010 (as amended) ('the 2010 Regulations'), and The Wildlife and Countryside Act 1981 (as amended) ("the Act")

IMPORTANT

This licence authorises acts that would otherwise be offences under the legislation referred to above. Failure to comply with its terms and conditions:

- i. may be an offence against the Act and the 2010 Regulations or mean that the licence cannot be relied upon. The maximum penalty available for failing to comply with a condition of a licence under the Act or the 2010 Regulations is, at the time of the issue of this licence, an unlimited fine and/or a six month custodial sentence; and
- ii. may result in this licence being revoked and/or the refusal to grant future licences.

If the activity that you wish to undertake is not covered by this licence, or if you are unable to comply with any of the terms and conditions which apply to the use of this licence, then you will need to apply to Natural England for an individual licence.

This licence is not a consent or assent for the purposes of Part II of the Wildlife and Countryside Act 1981 (as amended) in respect to Sites of Special Scientific Interest. It is your responsibility to get consent or assent if required (see Information and Advice note c).

Natural England hereby authorises¹ the Amphibian and Reptile Conservation Trust (ARC) (hereafter referred to as the 'Licensee') Address: 655A Christchurch Road, Boscombe, Bournemouth, BH1 4AP under section 16(3)(a) and section 16(5) of the Act and under regulation 53(2) (a) of the 2010 Regulations, being satisfied that as regards the purposes specified in this licence that there is no satisfactory alternative and that the actions authorised will not be detrimental to the maintenance of the populations of the species concerned at a favourable conservation status in their natural range, То Carry out the activities detailed in Annexes WML-OR10(a) and (b) for the following species: • Great crested newt (Triturus cristatus) Natterjack toad (Bufo calamita – now known as Epidalea calamita) • • Pool frog (*Pelophylax lessonae*) • Sand lizard (Lacerta agilis) Smooth snake (Coronella austriaca) Of the numbers and life stages specified in Annexes WML–OR10 (a) and (b) For the purposes of • science and education; Valid for the period 20 January 2016 and 31 December 2020 (inclusive) Area valid in All counties of England (landward of the mean low water mark) Subject to The Licence Conditions specified below. Definitions used in this The "Appointed Person" is an appropriately trained and experienced licence employee of ARC who is nominated to act as a single point of contact for Natural England with regard to this licence. The Appointed Person is expected to oversee use of the licence, including authorising Accredited Agents to act under the licence, and training, recording keeping and compliance. An "Accredited Agent" is an employee or a volunteer of ARC who has received appropriate training and is competent to undertake activities permitted by the licence and who is authorised to act under the licence by the Appointed Person. To carry out work they must be in possession of a letter signed by the Appointed Person authorising them by name as an Accredited Agent for the purposes of the licence. An "Assistant" is a person assisting the Appointed Person or an Accredited Agent. Assistants are only authorised to act under this licence whilst they are under the direct supervision of either the Appointed Person or an Accredited Agent. LICENCE CONDITIONS

Who may use this licence

- 1. The Licensee shall nominate an Appointed Person (see Definitions) whose details will be provided to Natural England to oversee use of this licence.
- 2. The following persons (see Definitions) are authorised to use this licence whilst engaged in official business of ARC:
 - a. The Appointed Person;
 - b. Appropriately trained employees and volunteers of the Licensee who are authorised to use the licence by the Appointed Person (hereafter referred to as "Accredited Agents");
 - c. Assistants acting under the direct supervision of the Appointed Person or Accredited Agent.
- It is the responsibility of the Licensee to ensure that all persons using this licence possess 3. appropriate knowledge and experience to undertake licensed activities in accordance with the terms and conditions of this licence and accepted best practice. It is the responsibility of the Licensee to provide suitable training to enable its Accredited Agents and Assistants to meet the

Natural England is authorised to exercise this power in accordance with an agreement made with the Secretary of State under section 78 of the Natural Environment and Rural Communities Act 2006

conditions of this licence (see Information and Advice notes d and e). They must also abide by the most up to date iterations of any guidance referred to in this licence.

- 4. Any Accredited Agents of the Licensee engaged in activity under the terms and conditions of this licence shall at all times carry a letter of authorisation signed by the Appointed Person, have access to a copy of this licence and produce it on demand to any police or Natural England officer.
- 5. The Licensee is responsible for <u>all</u> activities carried out under this licence, including activities carried out by Authorised Persons, Accredited Agents and their Assistants.

Working under the licence

- 6. Persons acting under this licence must abide by Annexes WML-10(a) and (b) of this licence.
- 7. All relevant animal welfare legislation must be complied with at all times (see Information and Advice notes f to h and the relevant annexes). It is the responsibility of the Licensee to ensure its Accredited Agents and Assistants use appropriate equipment (eg trap or net) and to ensure they are competent to use such equipment so as to avoid unnecessary suffering.
- 8. This licence does not permit any animals to be captured and moved for any other purpose than those specified in the general and special licence conditions and as set out in associated annexes (eg to facilitate development, construction type works or land management activities).

Recording and reporting requirements

- 9. It is a condition of this licence that the Licensee maintains:
 - a. A record of all activities carried out under the authority of this licence. This record must include the information required for each Annual Report to Natural England (see Information and Advice note i);
 - b. A record of all incidents where an activity has not been conducted in accordance with this licence and any remedial or corrective action taken; and
 - c. A record of the names of all persons trained and authorised to use this licence, including a note of when they were trained, what the training comprised and any refresher training received.

Records are to be kept for at least two years after the licence expires and are to be made available for inspection by Natural England at any reasonable time.

- 10. An Annual Report of activities conducted under this licence must be sent by the Licensee to Natural England (at the address given below) for the reporting period 1 January to 31 December (inclusive), no later than 31 January each reporting year, even if the licence is not used. ARC is also required to submit the following data annually within the same time periods above:
 - a. Survey data collected under this licence to the relevant Local Record Centres (the Licence Report template reference WML-LR-OR10 may be used for this purpose).
 - b. A list of all EPS possessed under this licence, including live animals (temporarily possessed) and dead specimens and derivatives to Natural England.

Licence compliance

- 11. The Licensee shall permit an officer of Natural England, accompanied by such persons as he/she considers necessary for the purpose, on production of his/her identification on demand, reasonable access to survey work being undertaken for monitoring purposes and to be present during any operations carried out under the authority of this licence for the purpose of ascertaining whether the conditions of this licence are being, or have been, complied with. The authorised personnel shall give all reasonable assistance to an officer of Natural England and any persons accompanying him/her.
- 12. Failure to comply with the terms and conditions of this licence (including the recording and reporting requirements) will, by default, render this licence null and void and it may not be relied upon until such time that Natural England confirms in writing that its use may resume.
- 13. Natural England must be informed of all breaches to this licence within 48 hours of the breach occurring. Unless advised otherwise by Natural England, the licensed organisation must take the necessary steps to address any breaches or poor practice identified as quickly as possible.

INFORMATION AND ADVICE

- a. Ordinarily, this licence will be re-issued every five years, but please note that it may be modified, extended, terminated or revoked at any time by Natural England or the Secretary of State, but this will not be done unless there are good reasons for doing so.
- A licence is not permission from Natural England for an activity that could damage a Site of Special Scientific Interest (SSSI). Anyone acting under this licence is not exempt from the provisions of Section 28 of "the 1981 Act". This means that owners and occupiers and Section 28G authorities ('Statutory undertakers etc.') are obliged to give notice to Natural England if they propose to carry out an operation likely to damage a SSSI. To identify SSSIs and the features for which they are designated, refer to www.magic.gov.uk. For further advice or to request consent / assent for an activity please contact the Natural England 'SSSI Adviser' for the relevant site(s). Contact details are available from the Natural England Enquiry Service (see below).
- c. The common name or names of species given in the licence and Annexes WML-OR10(a) and (b) are included by way of guidance only; in the event of any dispute or proceedings, it is the scientific name of a species only that will be taken into account.

Training requirements

- d. Training must be relevant to the conditions and the activities permitted by the licence and should be undertaken at regular intervals. This should include: identification of European and other Protected Species included in the scope of this licence and signs indicating they may be present; how to undertake a records search; the ability to identify a rare species and / or non-native species, or a population of significant importance; surveying techniques; best practice guidance and reasonable avoidance measures; a working knowledge of both the 2010 Regulations and the Act together with an understanding of offences that may be committed.
- e. It is the responsibility of the Appointed Person to ensure all Accredited Agents using the licence maintain their expertise at an appropriate level to act under this licence and it is also the Appointed Person's responsibility to ensure that Accredited Agents and Assistants have appropriate training, experience and instruction to act under this licence. Records must be kept (see Condition 9).

Welfare considerations

- f. No person convicted on or after 1 January 2010 of an offence under the Conservation of Habitats and Species Regulations 2010, the Wildlife and Countryside Act 1981, the Protection of Badgers Act 1992, the Deer Act 1991, the Hunting Act 2004, the Wild Mammals (Protection) Act 1996, the Animal Welfare Act 2006 or the Protection of Animals Act 1911 (all as amended) may use this licence without the permission of Natural England unless, in respect of that offence, either:
 - i. they are a rehabilitated person for the purposes of the Rehabilitation of Offenders Act 1974 and their conviction is treated as spent; or
 - ii. a court has made an order discharging them absolutely.
- g. Persons acting under this licence may photograph any protected species named in this licence in connection with licensed work provided that this causes no additional disturbance or any other harm.
- h. Under the Animal Welfare Act 2006 it is an offence to cause any unnecessary suffering to an animal under the control of man (section 4). This applies to the treatment of animals (including non-target species) held in nets etc.

Reporting

i. Annual reports (using Licence Report template reference WML-LR-OR10) should be emailed to Natural England, but they may also be posted (please mark 'Licence Returns' and send to the licensing email or postal address given in 'Contact Details').

The limits of licences

- j. Licences permit action only for the purposes specified on that licence.
- k. Licences do not permit actions prohibited under any other legislation, nor do they confer any right of entry upon land.
- I. Unless otherwise stated the provisions of Natural England licences only apply landward of the mean low water mark in England. The Marine Management Organisation is responsible for all licensing seaward of the mean low water mark.
- m. No work shall be carried out under this licence on a National Nature Reserve except with the prior written permission of Natural England's 'SSSI Adviser' for the relevant site(s) (contact details available from Enquiry Service – see below).

Compliance and enforcement

n. The Licensee is expected to monitor compliance with the licence and to take action in the event that poor

practice and / or non-compliance are identified. A person may be barred from using this licence by Natural England, for example, if that person breaches the conditions of this licence. In these circumstances Natural England will notify the Licensee.

- o. Any person to whom Information and Advice note g applies will require the permission of Natural England to use this licence. Any such application will be considered on its merits.
- p. Natural England checks compliance with licences and the attached conditions and where breaches occur will apply its published compliance and enforcement position (see Natural England's <u>Compliance and</u> <u>Enforcement Position.</u>

ANNEX A - WML-OR10 (a)

To undertake surveys for specified species for scientific (including research) and educational purposes



OVERVIEW

The licence Annex permits persons authorised under this licence to disturb and take great crested newts, natterjack toads, pool frogs, sand lizards and smooth snakes whilst surveying and monitoring when undertaking official duties for ARC.

The surveys will be undertaken:

- To establish presence / absence and / or population size class assessments of the above species
- As part of any ARC monitoring programme or project, including the National Amphibian and Reptile Recording Scheme (NARRS)
- As part of any training course or research project being carried out by ARC.

Activities permitted

- Surveys (including monitoring) of the species specified below involving
 - (i) Disturbance
 - (ii) Capture (Take)

Science and education

By the means specified in Table 1, while surveying

- (a) Great crested newt (Triturus cristatus)
- (b) Natterjack toad (Bufo calamita now known as Epidalea calamita)
- (c) Pool frog (*Pelophylax lessonae*)
- (d) Sand lizard (Lacerta agilis)
- (e) Smooth snake (Coronella austriaca)

Purpose(s) for which these activities may be conducted

IMPORTANT

These activities are subject to the terms and conditions set out in the main licence in addition to the Special Licence Conditions below.

SPECIAL LICENCE CONDITIONS

- 1. Any live animals taken under this licence must be liberated at the site of capture as soon as possible and always within 72 hours.
- 2. All holding containers must be clearly marked stating that the species is protected and has been taken from the wild under a licence from Natural England for scientific and educational purposes.
- 3. Any animal of a Schedule 9 species, which is not a native species, or of a species which is not ordinarily resident in England in a wild state, that is caught in a trap set under this licence must not be released or allowed to escape back into the wild; it must be humanely despatched, unless a specific licence to release that species has been obtained, or advice sought from Natural England's Wildlife Licensing Team before taking further action.

Great crested newts

- 4. Persons acting under this licence must abide by the most up to date iterations of the relevant species guidance (including advice on surveying and trapping). In this context the relevant species guidance includes advice within:

The definition of 'Take' for the purpose of this licence is to remove by hand, examine and replace at the site of capture. It <u>does not</u> permit the translocation of specimens, ie taking and moving to another place. These activities are only permitted if undertaken in an official capacity of ARC work / activities.

ANNEX WML-CL10(b)

To transport and possess for scientific and educational purposes



OVERVIEW

The licence Annex permits the transport and possession of live and dead specimens or derivatives of the species listed below, which would otherwise be an offence under regulations 41(3)(a) or (b) of the 2010 Regulations. These species must have been lawfully obtained, and a person is only covered whilst undertaking official duties for ARC.

As set out in Table 1 below.

- Species permitted
- (a) Great crested newt (Triturus cristatus)
- (b) Natterjack toad (Bufo calamita now known as Epidalea calamita)
- (c) Pool frog (*Pelophylax lessonae*)
- (d) Sand lizard (*Lacerta agilis*)
- (e) Smooth snake (Coronella austriaca)

Activities permitted

- Possession of live specimens of the above listed species for up to 72 hours;
- Possession of dead specimens and derivatives of the above listed species;
- (iii) Transport of the above listed species, dead specimens and derivatives of the above species.

Purpose(s) for which these activities may be conducted

IMPORTANT

These activities are subject to the terms and conditions set out in the main licence in addition to the Special Licence Conditions below.

Science and education

These activities do not cover translocation, re-introduction, breeding or re-stocking programmes, which will require an individual licence.

SPECIAL LICENCE CONDITIONS

- 1. Any live animals taken under this licence must be liberated at the site of capture as soon as possible and always within 72 hours.
- 2. Translocation (ie taking and moving to another place) of animals is not permitted under this licence.
- 3. All holding containers must be clearly marked stating that the species is protected and has been taken from the wild under a licence granted by Natural England for scientific and educational purposes.
- 4. Subject to the terms and general and special conditions of this licence, this licence only authorises the possession and transport of live or dead specimens and / or derivatives of the species listed in this licence that:
 - (i) are kept and transported for the purposes of science or education only, and
 - (ii) were taken from the wild in the European Community without breaching applicable legislation of the Member State in question (see Additional Information below).**Reporting requirements**
- 5. Each dead specimen and / or derivative sample (hereafter referred to as "specimens") being held or transported under this licence must be catalogued by ARC and a register of specimens and derivatives must be kept and updated on an annual basis in accordance with the requirements of Annex C. Details must be provided in the annual licence return to the Natural England Technical Services (Wildlife Licensing) including:

WML-OR10 [version December/2015 (amended Nov 2016)]

- The name of the individual holding and / or transporting the specimen;
- A description of the specimen;
- How the specimen was acquired and the reason for possession and / or transport; and,
- If the specimen is to be stored, the location of storage.
- 6. This information is to be made available for inspection at any reasonable time by Natural England.

ADDITIONAL INFORMATION FOR THIS ANNEX

This licence covers possession of specimens that were taken from the wild after 21 August 2007 without contravention of any applicable law of the Member State in which it was taken. In the UK for example, this would mean without contravention of relevant wildlife legislation such as the Habitats Regulations 1994, the Conservation of Habitats and Species Regulations 2010, the Wildlife and Countryside Act 1981, the Pests Act 1954 and the Animal Welfare Act 2006.
